

Hello Everyone, My Name is Rishika and I am from India. I have enrolled as a PhD scholar at the Karl Jespers Centre for Transcultural Studies in the Graduate Programme for Transcultural Studies.

My Research focuses on the rise of Alt-Right in India and effect that digital cultural products like 'memes' have in accelerating the reproduction of cultural and social capital of the Hindu Right or Hindutva in India. It studies how various alt-right groups across the globe effect the aesthetics and the content shared by the Hindu right online. My research aims to look into how memes, a type of digital content that thrives on existing cultural codes and the meta practice of 'fun' impact the way people form relations online and how they interact in and with contemporary Indian society, culture and its existing cultural codes. It also aims to analyse how members of this type of content can be used to motivated people to harass and incite violence.

Prior to my current pursuit, I have completed my Bachelors in Political Science from Delhi University and my Masters in Development Studies from Indian Institute of Technology, Guwahati

I am Yesum Chon from South Korea, a PhD student at the English Department under the supervision of Prof. Dr. Vera Nünning. I have a Bachelor degree in German and English literature from Hankuk University of Foreign Studies, and hold a Master's degree in English literature from Seoul National University. I arrived in Germany in January 2023, and started my PhD project.

My research is titled "Re-conceptualizing Bildung: George Eliot's English Contextualization of the German Tradition of Bildung". In my research, I intend to revisit most of George Eliot's novels, asking how far they initiate a new form of the Bildungsroman. The main goal of my research is to demonstrate the hypotheses that Eliot's novels are based on Friedrich Schiller's concept of Bildung, and that this concept anticipates Eliot's concept of Bildung and the idea of aesthetic teaching presented in her novels. I will explore how Eliot contextualizes and synthesizes Schillerian concept of Bildung with Herderian and Feuerbachian concept of sympathy in the English context, thereby presenting an alternative concept of Bildung. Thereby, I will examine how Eliot's narrative rhetoric reflects her views on aesthetic teaching and the value of literature, as an extension of reader's sympathy. Outside of my research work, I particularly enjoy visiting various art museums. Also, I love travelling a lot. I look forward to participating in the various events provided by HGGS. And I hope to expand my experience and knowledge by learning from fellow members.

Guten Tag, everyone,

My name is Ting Wang, from middle of China, specifically Wuhan, you all must know it. Now, I am a PhD candidate of sociology under the supervision of Prof. Dr. Markus Pohlmann.

My research topic is about corruption and anti-corruption in China and Germany, which is a comparative study. Honestly, the theme is so grand, in more detail, it is about organizational bribery in the two countries. The legal document about the bribery that can be obtained from the court as the starting point, the method of collective mindsets analysis (CMA) is used to analyze the causes and characteristics of bribery as actors. More importantly, the life choices of actors as individuals reflect the structure and history of society in a given environment. Obviously, institutions and laws have become the means of consensus regulation. However, in the process of institutionalization, the influence of culture, ideas and attitudes cannot be ignored. We are trying to figure out whether China, as some news criticized, uses a multilateral economics institution (AIIB) to serve its bilateral strategic initiative - Belt and Road Initiative (BRI) - akin to the way the US has done with the World Bank and IMF, by using a novel dataset that identifies the geographic location of AIIB and BRI projects. My second research project is to ask whether the existence of natural resources increases the possibility of conflicts in Africa, with geo-referenced data on oil resources and conflicts. The third project is still in the initial stage of ideas, in which we would like to explore the relations between weather shocks and children's welfare in India.

I am delighted to join the HGGS, where I will have the opportunity to be inspired by scholars and researchers from various disciplines. Looking forward to meeting everyone.
